5.1 TfB / LAF application. We resolved to progress the project and we will continue to liaise with Simon Garfield (BCC) and seek alternative funding to make up the shortfall funding.

5.2 Cemetery Report: A review of the condition of the cemetery was discussed. We resolved to set up a subcommittee to provide an administrative function to resolve the Burial Records and grave allocation plan. We will also have to assess the various trees in the cemetery for safety and then set up a working party to clear graves so that we can complete the grave record.
